Four-star councils implement all quality practices throughout the year to create a culture of career-focused opportunities in alignment with in-demand occupations and provide supporting data.



Three-star councils implement many quality practices throughout the year to create a culture of career-focused opportunities for all students.



Two-star councils implement few quality practices and/or show insufficient evidence of implementation. Some quality practices are present; however, there is room for growth in implementation.



One-star councils are in the beginning stages of implementing quality practices or implement very few quality practices.

“Business Advisory Councils create engaging opportunities for students to gain practical skills, connect with mentors, and learn about in-demand career skillsets in their communities,” said Stephen D. Dackin, director of the Ohio Department of Education and Workforce. “Partnerships between businesses and education are crucial for preparing
