These fundraiser forms should describe the approved fundraiser, estimate amounts to be collected, and list projected expenditures (if any) at the start of the fundraiser. Then, at the end of the fundraiser, the bottom portion of the fundraiser report should be completed with actual results.

## Medical, Dental, and Vision Open Enrollment

As a reminder, **open enrollment** will occur in November and December for health, dental, and vision insurance for a January 1st effective date. Employees who wish to add, change, or terminate health coverage may do so by contacting Kathy by December 31st. As in the past, a reminder e-mail will be sent out to employees in November when open enrollment begins.

#### **Insurance Rates:**

**Insurance rates** effective January 1, 2019, were approved by the Board at the October 17th Board of Education meeting and represent modest increases of 2.4% for medical, 0% for dental, and 3% for vision. As in the past, one-half of the premium will be deducted from each pay per month. An e-maill will be sent out with the updated rates. #### Flex Spending:

A reminder as you plan for the remainder of the calendar year that **flex spending** for 2019 resets beginning on January 1, 2019, and runs through December 31, 2019. #### **Building Tours**

Building tours throughout the District will be taking place from 5:00 pm - 7:00 pm on Wednesday, These tours will be open to the October 31st. community for anyone who would like an opportunity to tour the buildings prior to the November 6<sup>th</sup> ballot issue. District Board members and administration will be present at each building to provide tours beginning at 5:00 pm.

These building tours will provide an opportunity to see first-hand the condition of our buildings and the challenges our maintenance staff overcome every

Our facility bond issue will be one of the items put to a vote that day. As a reminder, this issue represents 8.6 mills for the bond and .5 mill for the maintenance levy required by the OFCC. The monthly cost per \$100k of home value calculates as \$26.54 per month.

The new facilities will provide state-of-the-art safety and security systems, modern science labs, the latest technologies, and 21st century learning **environments** for all students.
